Important Information, Policies, and Procedures for BCT Mailbox Holders

# What is a Commercial Mail Receiving Agency (CMRA)?

- A CMRA is a business that accepts and handles U.S. Mail on behalf of others. Base Camp Trenton (BCT) operates as a CMRA.
- An office business center (OBC) is a business that operates primarily to provide private office facilities and other business-support services to individuals or firms (customers). OBCs are considered CMRAs for USPS purposes.
  - BCT offers booking discounts to utilize both our shared and private spaces for all customers that have a mailbox with us. See your specific membership plan for more details.

## Key Definitions

- Addressee: That's you! The person or business to whom the mail is addressed.
- **PMB:** Private Mail Box.
- **PMB Number:** The unique number assigned to your mailbox. It's similar to a suite number.

# Addressee and CMRA Agreement

# PS Form 1583

#### For Addressee:

- □ **Completion:** Each mailbox user must complete this form BCT will provide this form to you. Spouses need separate forms and must provide ID.
- **Gignature Witness:** The form must be signed in front of a CMRA employee or notary.
- **ID Verification:** Provide current, valid primary and secondary IDs. The information must match your form.
  - Typically, a driver's license and passport are submitted as ID.
- **Form Changes:** If your information changes, submit a new PS Form 1583 with updated IDs.

#### For CMRA:

- ✓ **Record Keeping:** BCT keeps digital copies of forms and IDs for USPS inspection.
- ✓ **Database Entry:** BCT records your details in the USPS CMRA Customer Registration Database.
- ✓ **Quarterly Certification:** BCT certifies the accuracy of all customer forms quarterly.

### Mail Formatting

It is important that we know who each piece of mail is for. When sharing your business mailing address to receive mail, use the following address format:

Name or Business:	ABC CO.
Street Address, followed by PMB Number*:	
City, State, ZIP Code:	TRENTON, NJ 08611-1717

\*Note: The PMB number is important because if there is no addressee listed on a piece of mail, we will still be able to sort it based on the PMB number.

## **Termination**

- **Termination:** When you end your service with BCT, <u>do not</u> file a change-of-address with USPS. BCT will mark the termination date on your form.
- Forwarding: Per USPS guidelines, BCT will forward your mail for 6 months after service termination. Provide a forwarding address. If one is not provided, we will use the address listed on your most recently submitted PS Form 1583.
- **Return Mail:** After 6 months, BCT may refuse mail for former customers. This will be done by marking all unaccepted mail as "RETURN TO SENDER."
- Non-Compliance: If mail is returned by USPS as "Moved, Left No Address," BCT can return it to the Post Office.

# **PROHIBITED** <u>USPS-specific</u> services (NOT available to CMRA customers):

- \* **Premium Forwarding Service Residential (PFS-Residential):** Forward all mail to a temporary address weekly via Priority Mail. Not available to CMRA customers.
- Premium Forwarding Service Local (PFS-Local): Forward mail from your PO Box to a local street address within the same postal facility. Requires an annual fee and reshipment fee per container. Not available to CMRA customers.
